## NEW STANDARDS AND GUIDELINES

AIAG is debuting three new resources for FVL, including the **Electronic Proof of Delivery Guideline Version 2**, which establishes a process to allow real-time access and visibility of delivery data to all parties; the **Finished Vehicle Transportation Damage Standards and Guide**, which provides the latest industry guidelines to help automotive companies expedite the claims handling process; and the new **Finished Vehicle Logistics Quality Handling Manual**, developed in partnership with ECG, The Association of European Vehicle Logistics, which improves operations by optimizing activities and standardizing practices, leading to a reduction in damage rates and the more rapid and effective transporting of vehicles.

## COLLABORATION

AIAG has reached separate memorandums of understanding with the American Trucking Associations and the American Association of Port Authorities, which define a new level of cooperation and collaboration between AIAG and these organizations.

AIAG will engage with ATA in cooperative efforts for the betterment of the FVL industry, including holding regular joint discussions and sharing ideas for the development of FVL standards. Similarly, AIAG and AAPA will provide each other with mutual support for automotive-related port and logistics initiatives that are beneficial to both organizations.

AIAG also develops global relationships, and has worked with the Association of European Vehicle Logistics (ECG) since 2007 to develop common Damage Claims Standards and Guidelines.
